Multi – Day Charter Booking Terms and Conditions

Thank you for your booking, please read the following booking conditions, they apply to all bookings

Deposits and final payments

A deposit of 30% is required and all deposits shall be made within 14 days of the time of booking. If a deposit is not taken within 14 days then we reserve the right to put the trip back on the market. Final payment is required 6 weeks before departure and if not received by the due date we reserve the right to treat your booking as cancelled.

Cancellations

We reserve the right to cancel or vary any charter at any time. All voyages are subject to insufficient bookings, bad weather, breakdown or any other cause beyond our control. If we cancel a charter a full refund or a refund on the portion of days remaining of the charter will be given or you may transfer your booking to another Charter of the same duration.

Cancellation by you will result in loss of deposit.
Cancellation by you less than 30 days notice, 100% of total cost.

Insurance

We recommend that you take out travel insurance including cancellation insurance.

\$10m Public Liability insurance is held by Why Not Fishing Charters and it will remain current at the time of charter.

Emergency Conditions

Clients must bear their own costs for any emergency evacuation or rescue charges. Clients must provide emergency contact details.

Medical information

It is essential that you advise us if you have any special physical, medical or dietary requirements. Participation requires that you are in good health.

Behaviour

The passenger agrees to conduct themselves, in an appropriate manner not to cause disturbance, offence or inconvenience to other persons on board the vessel, nor engage in dangerous behaviour that will damage or compromise the safety & welfare of other persons or the vessel. The passenger will comply with all or any direction given by the master of the vessel. While we permit the moderate consumption of alcohol, excess drinking will not be tolerated.
